## Rec Assist 2025

---

The current Rec Assist fund is available Jan. 1, 2025 through Dec. 31, 2025. Applications accepted from Dec. 9, 2024 through Nov. 30, 2025.

A minimum 20 percent co-payment per class or program, per participant, is required at the time of registration. Your co-payment will be higher if you don't have enough Rec Assist funds remaining on your account to cover 80 percent of the activity/program fees.

Use of the Rec Assist fund is available on a first come, first served basis. You may use the amount on your account only until the Rec Assist Fund is depleted.

Once the Rec Assist fund is depleted you must pay full price for all registrations, even if you still have Rec Assist dollars on your account.

The total amount that a family qualifies for will be placed on the family account and may only be used by eligible family members.

## Who Is Eligible For Rec Assist?

You may only use one type of assistance to qualify for Rec Assist funds. All eligible family members will receive \$400 each in Rec Assist funds.

## Details Of The Rec Assist Program

---

Please allow five business days for your application to be processed. If you qualify, you will receive notification by email. The total shown is for your eligible family members to use between Jan. 1, 2025 to Dec. 31, 2025. You may qualify only once per year.

Rec Assist may only be used for Montgomery County Recreation classes and programs such as yoga, summer camps, swim lessons, swim passes and swim punch pass. (Note: you may purchase one swim punch pass per eligible family member per year with your Rec Assist funds.)

Rec Assist may not be used for sports team league fees; facility rentals; recreation gift cards; daily pool admissions; supplemental fees including security deposits, withdrawal fees, materials fees, late pick-up fees, or to purchase aquatic merchandise; a previous balance on your account and/or an adjustment of previous registrations.

Unused Rec Assist funds will be removed from your account on Dec. 31, 2025 or when the Rec Assist fund is depleted.

All Montgomery County Recreation withdrawal, transfer and refund guidelines apply.
