### Presentation and discussion included:

- Role of <u>Collaboration Council</u> in county
  - Partnership with other agencies etc (CC has convening power)
  - Disseminate local, county, fed dollars into community esp capacity-building for small entities
  - Using data to make informed choices
    - Triennial comm needs assessment wrapping up now
  - Youth engagement
- OST (out of school time) programs they sponsor:
  - Excel beyond the bell w/ Rec
  - Community and school based state funded programs (community centers, apt complexes)
- Support providers with funding and professional development and quality monitoring
- Offer youth-development training for providers / gov employees / young people > working from a strength-based perspective, not from a deficit perspective
- Dedicated community engagement dept as well as youth organizer position and community organizer position - building out a training series about how to implement their community engagement strategy
- Support countywide OST network > how to ensure access to OST programs for ages 3-24 that is equitable and sustainable
- Would like to increase sports offerings
- Current project: How much is MoCO spending on OST (both before/after school as well as weekends).

# 7:02pm - MCPS Middle School Sports Presentation (Bryan Walker)

Presentation and discussion included:

- History of MS sports in MCPS
- Three-tiered approach to MS sports:
  - 1. Intramural (IM) offerings are at discretion of each school's principal and activities exclusively at home school. Principals keep data on participation but that is not gathered by MCPS Central Office.
  - 2. Extramural
  - 3. Interscholastic (IS) parallel to HS JV/Varsity sports and includes travel to nearby schools for games
- Whether to offer IS sports to 6th graders, who in MCPS are not currently eligible
- Specific sports offerings
- Benefits of MS sports for students
- Historic participation stats (demand sometimes outpacing opportunity -( ex: recently, 92 tryouts for soccer at one MS, but only keeping 25 players)
- Structural limitations on MS sports:
  - State cap on participation hours / participation restricted to Tues/Weds/Thurs
  - Facility limitations re: number of gyms in middle schools
  - Transportation (teams mostly use private buses for travel to opponent schools)
  - Availability of coaches/officials

ACTION: For next meeting, think about whether we should be working on issues related to MS sports (possible ex: adding new MS sports, 6th-grade participation)
