1. Introductions

- a. Melanie brought the meeting to order, seconded by Tania.
- b. SSCAB members and members of the public introduced selves.
- 2. District 3 Police and Public Safety Update
 - a. Commander Cokinos presented updates.
 - b. Holiday task force.
 - c. Have taken a number of illegal firearms off the street.
 - d. One robbery: juveniles robbed another juvenile of a jacket near the movie theatre.
 - e. Still suffering retail theft issues, especially CVS and Walgreens, detergents, shampoos, and paper towels. Taking them to DC and re-selling at laundromats and other places.
 - f. Biggest issue right now is cars getting broken into. Some covert officers have been deployed. Caught a stolen vehicle at Cameron St garage there to steal others, a gun was present, and other examples.
 - g. We're definitely still fighting crime. So far a pretty safe holiday time experience.
 - h. A detail on Friday and Saturday night downtown with extra officers visible to ensure safety.
 - i. Officer Brandon McCloud on positive youth engagement.

3. Youth Safety Initiative

- a. Dr. Davis presented via Zoom.
- b. While violent crime victimization is down in 2024, opioid overdoses and suicide attempts rose.
- c. Opioid overdose emergency room visits age distribution getting younger.
- d. Getting people off of fentanyl is expensive and takes more than detox alone.
- e. Self-harm emergency department visits for patients under 25 years old were stable from 2018-2023.
- f. In 2023, a 14% increase in violent crime for victims under age 25 years, with a notable rise in 15-17 age group.
- g. Dramatic increase in motor thefts by individuals under age 25 years from 2019 through 2023.

- h. 74% of motor thefts in 2023 done by people under age 25 years.

 - ii. Online Portal Hate-Bias Incidents
 - 1. Last year, when Councilmember Evan Glass was Council President, he created the Anti-Hate Task Force which was made up of six cohorts representing the Muslim, Jewish, LGBTQ+, Black/African American, Latino/Hispanic and Asian American, Native Hawaiian and Pacific Islanders communities.
 - a. One of their recommendations was for the county to develop a more accessible system for reporting hate bias incidents.
 - b. Just last week MCPD launched an <u>anonymous online portal</u> to report non-emergency hate-bias incidents.
 - c. This is a great tool that will help keep our community a safe and welcoming place for all. Please help us spread the word.
 - iii. ICYMI: Montgomery County: Most Religiously Diverse in the U.S.
 - 1. <u>NPR recently reported</u> that Montgomery County is the most religiously diverse county in the United States.
 - 2. They had a great piece about New Hampshire Avenue in Silver Spring, Maryland being packed with houses of worship, and that it was nicknamed the "Embassy Row of Religions" and the "Highway to Heaven".
 - 3. As we enter the holiday season, we thought this was a nice piece and a reminder about the diversity in our county being our strength.
 - iv. New Year's Resolutions Rec Assist
 - 1. And finally, as you start making New Year's Resolutions Goals applications are now open for Rec Assist. Each year, the Montgomery County Department of Recreation provides eligible residents with up to \$400 in funds to use toward most Recreation classes, activities and memberships that have a cost associated with them.
