- 7:04 p.m. **Review/Approve minutes from 3.17.25 Meeting** minutes approved as shown 1st Paul Klee and 2nd Theresa Watkins
- 7:05 p.m. **Police Report;** Commander Dillman (D#6, Gaithersburg/MontgVllg), Commander Pallas (D#5, Germantown), Commander Satinksky (D#1, Rockville)
 - Overall Q1 2025 numbers are lower than 2024
 - Resources in the MCPD are still down community engagement of officers has been helpful
 - Traffic enforcement is increasing
 - Homeless mansion behind the District 5 has been dismantled and services offered to the homeless
 - Body cams on officers serve to help absolve officers of wrong doing on calls but are also being used to monitor officers more closely day to day while not on calls.
 - Crime on autothefts by youth is down 40%
 - More foot patrol and bike patrol used

- 7:21 p.m. **Topic: Drone as First Responder:** Captain Nick Picerno, Director of the Special Operations Division
 - Update on how the program is going UpCounty
 - What areas does it cover in Upcounty
 - Information shared on how the drone works, limitations and advantages
 - Drone (1) improves response times (2) more efficient at arrests (3) better decision making prior to officers arriving so they know better what the situation presents (ex. Call that a person was waving a gun at a convenience store but drone showed it was a cell phone)
 - Another site to be added to District 5 (Germantown) currently covers 2.5 sq miles used primarily in Urban areas
 - Can be used for fire and rescue as well due to thermal intelligence to help fire fighters see where the fire is heaviest so they know best approach to putting out fire

• Adding additional sites requires additional staff – looking for pilots that are certified to fly drones – may open up to non police staff.

- Upcounty coverage: 235 sq miles and 8 stations
- Each station is fitted for the geographic region (ex. Great Seneca Valley Park caught fire so they were able to deploy vehicles necessary for a brush fire).
- There is an automatic aid from surrounding counties like Frederick
- They assess community info every 7 years to ensure the proper equipment is on hand to facilitate services
- Replace old fire alarms with new ones that are sealed units lasts 10 years.

 American Red Cross program will go into homes to help replaced old fire alarms with new ones. Placement in bedrooms recommended
- Baking soda and fire blankets are always good to have on hand near any possible fire hazards- best not to try to fight a fire. Call 911 and exit all members out of the house
- Narcan access has helped reduce the amount of overdose victims
