- Goals:
 - Reflecting on the 2009 master plan to see how it has done in bringing jobs into the employment sector
 - Explore whether Germantown will still become a major jobs center
 - Community engagement
 - Work with the new Thrive 2050 master plan
- Outline of the sector and the transit networks that intersect with it
- Content to study
 - o Residential and retail growth
 - Employment market
 - o Transit networks in the region
 - Potential urban district
 - Zoning updates
 - Modelling future development
- Schedule

- Ask about how it intersects with Thrive since Thrive wasn't designed for us
 - Informing the development of villages
 - How can we get more amenities into these villages
 - O Strive for more density in some locations
 - Emphasize complete communities
 - Better pedestrian and bicycling experience
 - o More mixed-use
 - o Build out the transit center in Germantown Town Center

- Prepare for a potential red-line expansion
- Why was Germantown built out so differently?
 - Very residential-development-heavy
 - O Not close enough to the red line or other transit networks
 - Land economics
- Is the County taking any steps to encourage more employers to come to Germantown?
 - That's mostly MCED
- You keep hinting at the fact that it seems like the office complexes are not being used on Century Blvd. What can be done with all these new unused buildings that might revitalize this area?
 - Ratios in the sector plan of residential units to employment development in the 2009 plan may need to be reconsidered
 - o This could be proposed in an amendment, but this is beyond the scope of the study
- Ask about canvassing efforts and the feedback they are hearing from residents
 - Still in the early stages
 - Everyday canvassing if we move into a more formal amendment process due to limited capacity
 - Reached out to HOAs
 - o Mailers and emails
