# 7:05 p.m. Review/Approve minutes from 9.16 meeting – Minutes as shared with one change to roll call and file name were made and accepted unanimously.

### 7:08 p.m. Police Report

1<sup>st</sup> District Commander Dillman

- Thanks to the UCAB for being involved in discussion of youth crime
- S. America "death group" is burglarizing high dollar home neighborhoods. Very organized, entering 2<sup>nd</sup> story bedrooms and steeling jewelry, safes, and high end bags around 7-9pm when residents are not home.
- 5th District Commander Pallas
  - Open house was successful
  - Juveniles still involved in many cases of car theft waiting in car dealer lots after hours, but were able to get children services involved with some of the new legislation
- 6th District Commander Stancliff
  - New hire in police department went above and beyond in their duty to uncover guns and criminal activity
  - Drones are now operational across six districts, extending up to three miles (limited by battery life)

Topic: Councilmember at Large, Evan Glass will discuss legislation he has worked on, bills he is currently working on, and other issues he plans to work on.

- Riverworks Art Center event update (October)
- Drone Program 1<sup>st</sup> responder program delayed for Upcounty. Command center in Derwood for UpCounty Region – will be coming on board in the new year. Used to address officer shortages and resident preferences for reduce police interactions. SS first city to use drones
- Public Nuisance Legislation noise monitoring due to modified vehicles pilot program will roll out in new year. Germantown will receive a monitoring station along with two other areas down county.
- Safe Streets Act Discussed a bill aimed at reducing pedestrian fatalities and injuries including:
  - Prohibit right turn on red in high-risk areas
  - Increase time for pedestrians to cross the street

- Safety reviews walking to and from school
- Reliance on automated cameras
- Noted that 400 pedestrians were struck with 19 fatalities.
- Climate Action Environmental Resiliency
  - MoCo carbon emission reduced 100% by 2035
    - 42% from transportation
    - 50% infrastructure in buildings
    - Focus on energy performance standards (BEPS) for buildings over 25Ksqf to encourage green initiatives, especially in hospitals and healthcare networks.
    - Acknowledged that some entities require fossil fuels.
    - Need to address how we compel hospitals and healthcare networks to implement climate-friendly initiatives without raising their fees for building infrastructure change costs. (we are the 3<sup>rd</sup> largest biotech sector in the country).
    - Reforestation tree canopy needs to look at tree replacement when trees are cut down.
- Infrastructure Improvements Plans to simplify processes for neighborhood infrastructure requests, such as speed bumps and stop signs, to promote community safety without requiring a supermajority for approval.
- Housing Strategy: Initiated a discussion on attainable housing for middle-income residents, referencing a Washington Post article. No formal proposals are currently before the council.
- Transportation Concerns: Highlighted ongoing challenges with the American Legion Bridge and the lack of funding for the last six years. Funds diverted to rebuilding of FS Key Bridge in Baltimore.
- Drones: In response to questions about the impact of intermittent Wi-Fi and cellular coverage throughout the County, EG noted that drones are fully self-sufficient and do not rely on Wi-Fi.
- M83 Road Project: Project delayed for decades, with no recent funding. Not likely to materialize.

County Council Report

- Aaron Kraut (Luedtke's office)
  - update on the Damascus Placemaking Festival held on October 19-20. Event hosted to support local businesses and build up Damascus. Attendees included small businesses, residents, and visitors. Initiative designed to help create a clear vision for Damascus
  - Obtainable housing briefing occurring next week
- Craig Wilson (Balcolm's office)
  - Public meeting on Wednesday re: m-83 at 6pm at Neelseville MS

Regional Director's Report – Ruben Rosario

- Reported shooting in Montg Vllg and a town hall ensued to address community concerns about police presence. Community questioned limited police presence. In attendance were mental health professionals, community advocates, leaders and concerned parents. Announced plans for a public safety meeting.
- Oktoberfest in Germantown was a success (black Rock delivered a presentation)
- Upcoming events include the parade at Poolseville (Oct 21) and upcoming health gala which will feature an online auction.

Community Concerns - none were raised

Approve BCC Questionnaire - the Questionnaire was reviewed by members and approved

Quality of Life Subcommittee Update – Steve Augistino shared insights from a panel on juvenile crime, focusing on increasing access to safe recreational activities to deter youth from criminal behavior.
