



The project maps shown in the following slides are not inclusive of all traffic safety projects in the area. Projects that are not on the maps:


- Residential traffic calming projects

#### Major roadways with speed limits lowered


- Georgia Ave 35 & 40 MPH
- Norbeck Rd 35 & 40 MPH
- Connecticut Ave 35 MPH



# **Traffic Signals and Pedestrian Beacons**

#### **Protected Crossings across Major Roads**


- Bel Pre Rd 3 pedestrian hybrid beacons installed
- Twinbrook Pkwy 2 pedestrian hybrid beacons installed
- Aspen Hill Rd 1 pedestrian hybrid beacon installed
- Georgia Ave 2 traffic signals installed
- Randolph Rd 3 traffic signals installed



## **Corridor Projects**

#### Projects with multiple sub-projects along a road


- Aspen Hill Neighborhood Greenway traffic calming treatments to create a neighborhood connection for comfortable biking without creating separated bicycle facility.
- Veirs Mill Road Bus Rapid Transit + Pedestrian/Bicycle Facilities – improved crossings plus continuous sidewalks.
- Bel Pre Road Safety Audit audit complete and moving into design. Preliminary design supported through regional grant.
- Randolph Road Safety Audit audit complete (final report pending) between Georgia Ave and Connecticut Ave.
- **Georgia Avenue** ongoing coordination with State Highway for finding long-term solutions after short-term improvements made with lower speed limits.



## **Community Sidewalk Requests**

#### Map shows pending requests for sidewalks

Within the AHCA boundaries, one request along Farnell Drive from Holdridge Road to Gould Road. This is in the first step of the sidewalk request process for a field review.

#### **Promoting Safe Rides Home**

- Over 290 DUI arrests for eight-week task force.
- Over 900 people utilized <u>SoberRide</u> in DC area for New Year's Eve.
- <u>Outreach to bars and restaurants</u> with free coasters with safety message.
- Continued to update <u>Safe Ride Home</u> <u>page</u> to provide one stop shop for finding sober ride options in Montgomery County.














## **Heads Up/ Phones Down Video Contest**


